1. Do not use **JP Ultra** or any other additive unless you have received, and reviewed the product's MSDS sheet.
2. Do not use water from any mix tank that is used for **JP Ultra** for drinking, washing of face, or hands, flushing of eyes, or for any other personal hygiene purpose.
3. Do not use water from any mix tank that is used for **JP Ultra** applications, for any reason other than cleaning or flushing sanitary sewer lines, unless the tank and all related equipment (i.e., plumbing, pump, hose) have been completely emptied of **JP Ultra** solution and thoroughly rinsed with fresh clean water.

Precautions: Wash thoroughly after handling. Wear eye protection, protective clothing, protective gloves.

IF ON SKIN: Wash with plenty of water. If skin irritation occurs: Get medical advice/attention.
